We will try to respond to you as soon as possible, but we will always reply to you within 30 days of receiving your request. Applicable legislation and the GDPR Regulation, resp. The law provides you with in particular:

Right of access - You have the right to request confirmation from us whether your personal data is being processed and, if so, to obtain a copy of this data and the additional information resulting from Art. 15 Regulations, resp. § 21 of the Act. If we collect a large amount of data about you, we may require you to specify your request for the range of specific data we process about you.
